I Ebenezer Arvill of North Providence in the Rhode
Island District of North Providence on solemn oaths
do declare & say that in the month of April
1778 I enlisted as a private soldier in
Capt. Hopkins Company & Col. Johnsons Regiment
in the Continental Army of the United States
in the Rhode Island line In which service
I continued nine months & fifteen days
then not following - being the whole of the
time for which I enlisted - I never recd
any formal discharge in writing but was
discharged by verbal order with the rest
of the Regiment. I further declare that I
am now in reduced circumstances & stand
in need of the assistance of my Country
for support.

On this first day of August 1820, personally appeared in open Court, being a Court of Record, within and for said District Ebenezer Averis - aged 68 years, residing in the town of North-Providence in said County District who being first duly sworn according to law, doth on his oath declare, that he served in the Revolutionary War as follows:

That he served One Year and Nine Months in Col. Elliotts Regiment of the Rhode Island Line

that he made a previous declaration on the fourth day of April 1818, and that he has received a certificate for a pension, being No. 2968 And I do solemnly swear, that I was a resident citizen of the United States on the eighteenth day of March, one thousand eight hundred and eighteen; and that I have not since that time, by gift, sale, or in any manner whatever, disposed of my property, or any part thereof, with intent thereby so to diminish it, as to bring myself within the provisions of an Act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States, in the revolutionary war," passed on the eighteenth day of March, one thousand eight hundred and eighteen: that I have not, nor has any person in trust for me, any property or securities, contracts or debts, due to me; nor have I any income other than what is contained in the Schedule hereto annexed, and by me subscribed.

On this sixteenth day of April 1860 personally appeared before me Judah Hammond a justice of the Marine Court of the City and County of New York the same being a court of record Sarah Averell a resident of the City and County of New York formerly a resident of Newport in the State of Rhode Island aged Eighty three years who being first duly sworn according to law on her oath doth make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed July 4th 1836 - That she is the widow of Ebenezer Averell deceased who was a private Soldier in the army of the United States during the revolutionary war - She further declared that she was married to the said Ebenezer Averell on the eighteenth day of May one thousand seven hundred and seventy five of which marriage is annexed hereto a duly authenticated copy of the Church records of the 2^d Baptist Church in Newport aforesaid certified by Daniel S. Deane Clerk of said Church and Clerk of the Court of Common Pleas for the County of Kent in the State of Rhode Island - That her husband the aforesaid Ebenezer Averell died on the or about the 18th day of October in the year 1820 at Providence Rhode Island and that she has remained a widow ever since that period as will more fully appear by reference to the proof hereto annexed. The said Sarah Averell being unable to appear in court by reason of bodily infirmity this declaration is made out of Court before me justice as aforesaid and I hereby certify that the said Sarah

is in my opinion a person of credibility and as such
entitled to confidence. And I further certify that said
Sarah Howell stated that her said husband at the
time of his death had been a pensioner under
the act of March 18. 1838 as she understood
and believed.
